I understand that reasonable precautions will be exercised by the adults chaperoning each event and that adults will adhere to the Safe Environment policies of Avery Presbyterian Church at all times.

I hereby give permission for this child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in church activities. I understand that drivers for all events must be over age 21 and approved by Avery Presbyterian Church Director of Youth and Family Ministries or the Pastor.
